How to create your legacy with FMA:

- **GIFT IN YOUR WILL OR TRUST:** Making a charitable bequest to FMA is easy to arrange, costs nothing now, and keeps you in control of your assets.
- **GIFT BY DESIGNATION:** Simply name FMA as a percentage beneficiary of your Individual Retirement Account (IRA), 401(k), or other qualified pension plan.
- **DONOR-ADVISED FUND (DAF):** Name FMA as a percentage beneficiary of your account, with the remainder for your children to continue your philanthropy.
- **LIFE INSURANCE:** Name FMA as the owner and beneficiary of an existing policy you no longer need and receive a tax deduction for your gift.
- **GIFTS OF STOCK OR REAL ESTATE:** Gain significant tax benefits while supporting works of charity by gifting publicly traded securities or real estate, whether outright or deferred.
- **LIFE INCOME GIFTS:** A charitable gift annuity or charitable remainder trust can provide you with lifetime income, savings on capital gains, and a tax deduction.
